# **PETITION**

This is a petition to ask the church to make a statement about the use of aborted babies in vaccines.

### Background:

Around the world there is an increasing push to remove the ability for people to decline vaccines for themselves or their dependents for religious reasons. Why? **Because no churches have statements objecting to vaccines for any reason.** 1, 2 However, there are valid reasons why people would object to vaccines—the foremost of which is the use of aborted babies in vaccines. If churches would make statements about the use of aborted babies in vaccines it would empower those who would decline vaccines to do so. It would also provide assistance in the fight against government mandated or coerced vaccination and even to appeal to private businesses to rethink their coercive policies. 3

#### Outline:

This petition covers three points:

- A. Vaccines use cell lines from aborted babies.
- B. Abortion is murder.
- C. Human fragments from the cell lines contaminate the vaccines and are a risk to health.

Therefore, we need freedom from coercion and the ability to decline vaccines for conscientious (including religious, philosophical and personal-belief) reasons.

To be clear, this is not a pro vs. anti vaccination petition but a petition designed to fight against government *mandated* vaccination in favour of parental/personal choice.

# This petition shows that:

## Vaccines use cell lines from aborted babies:

1. Fetal cell lines have been used in the development, manufacturing and/or testing of the vaccines listed in Appendix A. These cell lines represent individual children who were aborted.

# Abortion is murder:

- 2. Life begins at conception: <u>Luke 1:44</u> "We exist as a continuum of human life, which begins at fertilization (conception) and continues until death...At any point in time, during the continuum of life, there exists a whole, integrated human being!"4
- 3. God prohibits murder, "You shall not murder." Exodus 20:13
- 4. His prohibition against murder extends to the unborn: <sup>22</sup> "If men fight, and hurt a woman with child, so that she gives birth prematurely...if any harm follows, then you shall give life for life, <sup>24</sup> eye for eye, tooth for tooth, hand for hand, foot for foot, <sup>25</sup> burn for burn, wound for wound, stripe for stripe. Exodus 21:22-25
- 5. Abortions booked to end a life differ from abortions booked to provide fetal cell lines for

vaccines: they have to be pre-arranged in order that scientists can be on hand to immediately preserve the tissue. The methods used are heinous, often involving dissecting a baby born alive with no anaesthesia as anaesthesia would effect the tissue that they are trying to preserve. 5, 6

- 6. The vaccine industry incentivizes abortions: The Dutch company that developed the aborted baby cell line PER.C6, Crucell (now Janssen), wanted to create additional cell lines in order to create vaccines for HIV, Ebola and other viral diseases. It approached the district health board in Wellington, New Zealand in order to negotiate a contract for the supply of 30,000 aborted babies annually. When the contract fell through, Crucell approached the Queen Elizabeth Hospital in Adelaide, Australia for the supply of up to 90,000 babies annually. Abortion doctors would be paid an hourly rate. Hospitals would receive an upfront fee for overheads and a substantial success fee if researchers were able to produce a viable cell line. The economics of such contracts would create an incentive to recommend and push women towards abortions.7
- 7. It was not "just two abortions from back in the 60s":
  - WI-38 (WI=Wistar, 38=38th baby) was conceived to married parents who thought they had too many children. She was three months gestation in 1962 when she was aborted and dissected in Sweden and her lungs sent to the USA. [Number of babies aborted to create this cell line: >23] RA 27/3 (R=Rubella, A=Abortus, 27=27th baby, 3=3rd tissue explants) was aborted at three months in 1964 during a rubella outbreak in the USA. Her 25-year-old mother was advised to have an abortion because she had contracted the disease. The rubella virus was isolated from RA 27/3's remains. The aborted babies from sixteen other mothers similarly advised turned out not to have rubella. [>80] MRC-5's 27-year-old mother was given an abortion for psychiatric reasons in 1966 in England. [Unknown] HEK-293 (HEK=human embryonic kidney cells, 293=the number of the experiment) was developed in 1973 from the kidney cells of an aborted Dutch baby girl. [Likely >100] PER.C6 was 18 weeks when s/he was aborted in 1985. He was simply unwanted. He was dissected and his retinal tissue frozen in liquid nitrogen until 1995 when the cell line was created. [Unknown] WALVAX-2 was aborted at three months in 2015 because her 27-year-old mother had a scar in her uterus from a previous caesarean birth. [At least 9]8, 9, 10, 11, 12, 13, 14, 15
  - The cell lines currently in use are being replaced by new cell lines from new aborted babies: PER.C6, WALVAX-2 and two other cell lines, IMR-90 and IMR-91 were developed from aborted babies specifically to replace the aging cell lines MRC-5 and WI-38 which won't last forever. Some of the other fetal cell lines that have also been developed for vaccines are WI-44, MRC-7, MRC-9, TIG-1, HER 911 and KMB-17. Every one of these represents an untold number of abortions.
- 8. There are some who elevate the concept of the need to vaccinate for the greater good and as a way to love one's neighbour as the highest ethical consideration.
  - Biblically we need to remember that we love our neighbour through the law by fulfilling the law. Romans 13:8, Romans 13:10, Galatians 5:14, James 2:8 The law says do not murder. Taking vaccines that utilize the products of murder, creates a demand for further abortions to replace the current fetal cell lines in order to create more vaccines. Therefore such vaccines are to be resisted and avoided. The unborn are our neighbours too and represent lives we should be trying to preserve. They are not a commodity or an ingredient. We cannot "need" a product if it requires the death of our neighbour to fulfil this need. Our need

- is to find or ask for an alternative or do without.
- Taking a vaccine for the greater good to protect infants, the elderly and the immunecompromised would only be helpful if vaccines stopped infection and transmission. But according to a world expert and vaccine inventor, they don't. "In fact, while most vaccines may prevent people from becoming sick, they don't prevent one from becoming infected or passing the virus to others."17

Human fragments from the cell lines contaminate the vaccines and are a risk to health:

- 9. Human traces remain in the vaccines:
  - "The use of fetal tissue in vaccine development is the practice of researching, developing, and producing vaccines through growing viruses in cultured (laboratory-grown) human fetal cells. The viruses generally burst these cells to be released. Although the vaccines are purified from the resulting cell debris, traces of human DNA fragments inevitably remain."18
  - Vaccine inserts acknowledge that human traces remain in the vaccines. "This product also contains residual components of MRC-5 cells including DNA and protein. "19, 20
  - The quantity of human remains in the vaccines is regulated (to 10ng/dose)21 however the quantity that actually remains is well above the regulated amount (142 to 2000ng/dose)22. There can be more human DNA than viral DNA in vaccines (8:1 human DNA to chickenpox DNA, for example, in the varicella vaccine).23
- There are risks associated with the human fragments from the fetal cell lines: The fetal DNA contaminants in vaccines can integrate into the genome of the vaccinated person24 causing insertional mutagenesis25, various cancers26, 27, 28, 29 autoimmune disorders30 and other disorders.31 Many governments are indemnifying the vaccine manufacturers and some governments are doing this without setting up any compensation scheme. So those who do experience an adverse reaction will be on their own.

#### Clarification:

This petition has only addressed issues as they relate to the aborted baby parts in vaccines. It has not raised possible valid conscientious objections as they relate to the other ingredients 32, the recommended schedule or any other issue.

### Conclusion:

Vaccines use cell lines from aborted babies. Abortion is murder. Human fragments from the cell lines contaminate the vaccines and are a risk to health. Therefore, we need freedom from coercion and the ability to decline vaccines for conscientious (including religious, philosophical and personal-belief) reasons.

- B. Communicate with politicians responsible for health, requesting:
  - That vaccines contracted for use in our country are not developed, manufactured or tested on cell lines developed from the remains of aborted babies.
  - That vaccines are only ever voluntary, not coerced on or mandated on individuals or their dependents and that individuals are always free to decline vaccines for conscientious (including religious, philosophical and personal-belief) reasons.

Or do otherwise as in their wisdom they may consider appropriate.

#### Notes:

A All of these vaccines were manufactured using fetal cell lines in such a way that they may contain human DNA fragments, except for:

- the Moderna Covid-19 vaccine. However, it relied heavily on the use of a fetal cell line in the design, development of the spike protein and testing.
- the Pfizer and Novavax Covid-19 vaccines which used fetal cell lines in testing and ongoing quality control.V, W
- B. We have not looked into other Covid-19 vaccines not listed above. As others become available, footnotes O and S may be reliable sources to let you know whether these too have an association with fetal cell lines.
